* WITHDRAWAL PROCESS *

 FOR EXAMPLE, IF YOU INVESTED 1,000 USDT, YOUR TOTAL WITHDRAWAL AMOUNT

- YOU MUST FIRST REINVEST YOUR PRINCIPAL AMOUNT (1,000 USDT) BEFORE WITHDRAWING THE TOTAL (1,150 USDT).
